11.1. Information on toxicological effects

Symptoms: Signs of toxicity in laboratory animals given sulfentrazone included clonic convulsions, ataxia, hypersensitivity to touch, chromorhinorrhea, abdominogenital staining, decreased locomotion, lacrimation, nasal discharge, and squinting eyes.

11.2. Delayed and immediate effects as well as chronic effects from short and long-term exposure

Chronic toxicity: Sulfentrazone Prolonged exposure cause decreased hemoglobin content and hematocrit, and increased spleen weight and splenic extramedullary hematopoiesis at high doses in animal studies. Prodiamine: In long-term feeding studies, toxicity was identified in the liver and thyroid of rats at 3200ppm, where decreased body-weight gains, liver enlargement and alterations, and species specific benign thyroid tumors were seen. At 5000 ppm in mice, both decreased body weight gains and increased liver weights were reported, but no compound related tumors were

Sulfentrazone: Fetal weight decreased; delayed skeletal ossification observed at maternally non-toxic doses are reversible effects and a dose-response is established; malformations observed in fetuses at maternally toxic doses and consistent with the mode of action for protoporphyrongen oxidase inhibitors.
